**ORDINANCE GRANTING AMNESTY ON SURCHARGES AND INTERESTS
OF DELINQUENT BUSINESS TAXPAYERS IN THE CITY OF MARIKINA

WHEREAS, Article II, Section 20 of the 1987 Philippine Constitution states that, "The State recognizes the indispensable role of the private sector, encourages private enterprise and provides incentives to needed investments;

WHEREAS, Section 18 of Republic Act No. 7160 or the Local Government Code of 1991 gives local government units power to create their own sources of revenues and to levy taxes, fees and charges which shall accrue exclusively for their use and disposition and which shall be retained by them;

WHEREAS, this power to grant amnesty is provided in Section 192 of the Local Government Code of 1991 which states that:

"x x x Local government units may, through ordinances duly approved, grant tax exemptions, incentives or reliefs under such terms and conditions as they may deem necessary x x x"

WHEREAS, on July 6, 2022, the 10th City Council of Marikina enacted Ordinance No. 064, Series of 2022 which provided for the grant of amnesty on surcharges and interests of delinquent taxpayers until December 31, 2022;

WHEREAS, businesses in the City of Marikina needs more time to recover from the COVID-19 pandemic, hence an assistance by granting relief in the form of amnesty is necessary;

WHEREAS, the grant of tax amnesty is adopted to boost the City Government's tax collection efforts and as a relief to taxpayers who are experiencing financial difficulties;

NOW, THEREFORE, BE IT ORDAINED, AS IT IS HEREBY ORDAINED BY THE SANGGUNIANG PANLUNGSOD OF MARIKINA in session duly assembled, that:

SECTION 1. The City Government of Marikina hereby grants one hundred percent (100%) relief or amnesty on surcharges and interests of delinquent business taxpayers until March 31, 2023.

SECTION 2. *Period of Availment.* The grant of amnesty to the surcharges and interests of delinquent business taxpayers is until March 31, 2023.

SECTION 3. *Repealing Clause.* All ordinances, rules, regulations and other local issuances inconsistent with this Ordinance, or any provision hereof, are hereby repealed or modified accordingly.

SECTION 4. *Separability Clause.* If, for any reason or reasons, any part of this Ordinance shall be held unconstitutional or invalid, other parts or provisions hereof which are not affected thereby shall continue to be in full force and effect.

SECTION 5. *Effectivity.* This Ordinance shall take effect immediately upon its approval.


