ORDINANCE WAIVING PENALTIES AND INTERESTS FOR UNPAID AMORTIZATIONS ON EMERGENCY RELOCATION CENTERS AND PERMANENT SETTLEMENT SITES AS A FORM OF TAX RELIEF TO THE BENEFICIARIES DURING THE PERIOD OF ENHANCED COMMUNITY QUARANTINE

WHEREAS, President Rodrigo R. Duterte on 16 March 2020 declared a State of Calamity throughout the entirety of the country through Presidential Proclamation No. 929 due to the 2019 Novel Coronavirus Disease (COVID-19) pandemic;

WHEREAS, Executive Secretary Salvador C. Medialdea, by Order of the President, issued a Memorandum dated 16 March 2020 imposing an Enhanced Community Quarantine over the entire Luzon including the National Capital Region including the City of Marikina, thus causing the temporary closure of businesses and work in both the public and private sectors;

WHEREAS, the City of Marikina recognizes that persons natural and juridical are rendered without sustainable income during the period of the Enhanced Community Quarantine;

WHEREAS, Section 192 of the Local Government Code of 1991 provides that:

“Authority to Grant Tax Exemption Privileges. – Local government units may, through ordinances duly approved, grant tax exemptions, incentives or reliefs under such terms and conditions, as they may deem necessary.”;

WHEREAS, the City of Marikina deems it necessary to grant tax reliefs on penalties and interests for unpaid amortizations on Emergency Relocation Centers and Permanent Settlement Sites (ERC/PSS);

NOW THEREFORE, BE IT ORDAINED AS IT IS HEREBY ORDAINED by the SANGGUNIANG PANLUNGSOD NG MARIKINA in session duly assembled, that:

SECTION 1. Title. – This Ordinance shall be known as the “Ordinance Waiving Penalties and Interests for Unpaid Amortizations on Emergency Relocation Centers and Permanent Settlement Sites as a Form of Tax Relief to the Beneficiaries during the Period of Enhanced Community Quarantine”.

SECTION 2. Tax Relief. – All penalties and interests for unpaid amortizations on lands classified as Emergency Relocation Centers (ERC) and Permanent Settlement Sites (PSS) incurred during the period of Enhanced Community Quarantine, which is from March 17, 2020 to April 12, 2020, are hereby waived as a form of tax relief.

SECTION 3. Separability Clause. – Should any portion of this Ordinance be deemed unconstitutional or be declared unlawful or in conflict with existing laws superior to this Ordinance, it shall have no nullifying effect on other portions or provisions of this Ordinance.

SECTION 4. Effectivity. – This Ordinance shall take effect immediately upon its approval.


