WHEREAS, on March 25, 2020, the City Council enacted Ordinance No. 033, Series of 2020 which provided for the waiving of penalties and interests for unpaid transfer taxes as a form of tax relief to the beneficiaries from March 17, 2020 to April 12, 2020 due to the enhanced community quarantine;

WHEREAS, however, President Rodrigo Duterte extended the Enhanced Community Quarantine in National Capital Region, Central Luzon and CALABARZON until May 15, 2020 to stop the spread of COVID-19;

WHEREAS, the impact of the prolonged enhanced community quarantine brought about the closure of unnecessary business establishments and the stoppage of work of most people, including the constituents of the City;

WHEREAS, Section 16 of the Local Government Code, or the General Welfare Clause provides that every local government unit shall exercise powers necessary to ensure and promote, among other things, social justice and preserve the comfort and convenience of their inhabitants;

WHEREAS, Section 192, of the same Code provides that, “Local Government Units may, through ordinances duly approved, grant tax exemptions, incentives or relief under such terms and conditions as they may deem necessary”.

NOW THEREFORE, BE IT ORDAINED AS IT IS HEREBY ORDAINED by the **SANGGUNIANG PANLUNGSOD NG MARIKINA** in session duly assembled, that:


SECTION 1. Section 2 of Ordinance No. 033, Series of 2020 is hereby amended to read as follows:

“**SECTION 2. Tax Relief.** – All penalties and interests for unpaid transfer taxes incurred during the period of Enhanced Community Quarantine, which is from March 17, 2020 to May 15, 2020, are hereby waived as a form of tax relief.”

SECTION 2. Effectivity. – This Ordinance shall take effect immediately upon its approval.
