BE IT ORDAINED, AS IT IS HEREBY ORDAINED BY THE CITY COUNCIL OF MARIKINA, in session duly assembled that;


SECTION 1. Section 8 of Ordinance No. 048, Series of 2020 is hereby amended to read as follows:
