ORDINANCE SETTING A NEW DEADLINE FOR THE PAYMENT OF REAL PROPERTY TAX FOR THE FIRST AND SECOND QUARTERS FOR CURRENT YEAR 2020

WHEREAS, the Sangguniang Panlungsod of Marikina enacted Ordinance No. 076, Series of 2020 entitled “ORDINANCE EXTENDING THE DEADLINE OF PAYMENT OF TAXES, FEES AND CHARGES IMPOSED AND COLLECTED IN MARIKINA CITY PURSUANT TO REPUBLIC ACT NO. 11469, OTHERWISE KNOWN AS THE ‘BAYANIHAN TO HEAL AS ONE ACT’”;

WHEREAS, payment of the real property tax for the first quarter was extended until June 30, 2020 without the imposition of penalty or interest;

WHEREAS, given the fact that the National Capital Region is still under a general community quarantine due to the Covid-19 pandemic, there is a need to set a new deadline for the payment of real property tax to afford the taxpayers to regain financial stability and allow them ample time to settle their obligations;

NOW, THEREFORE, BE IT ORDAINED by the Sangguniang Panlungsod of Marikina in session duly assembled that:

SECTION 1. *Payment of Real Property Tax.* The payment of real property tax for the first quarter which is due on June 30, 2020 as extended, is set to a new deadline payable not later than August 28, 2020, without incurring interests and penalties. The payment of real property tax for the second quarter is likewise payable not later than August 28, 2020.

SECTION 2. Coverage. This Ordinance covers the payment of real property tax for the first and second quarters of the current year. Unpaid taxes for the previous years shall not be covered by this Ordinance.

SECTION 3. Implementation. The City Treasurer and the City Assessor are hereby tasked to implement the provisions of this Ordinance.


SECTION 4. Separability Clause. If any provision of this Ordinance be declared unconstitutional or illegal by any court of competent jurisdiction, those parts which are not affected thereby shall continue to be in full force and effect.
